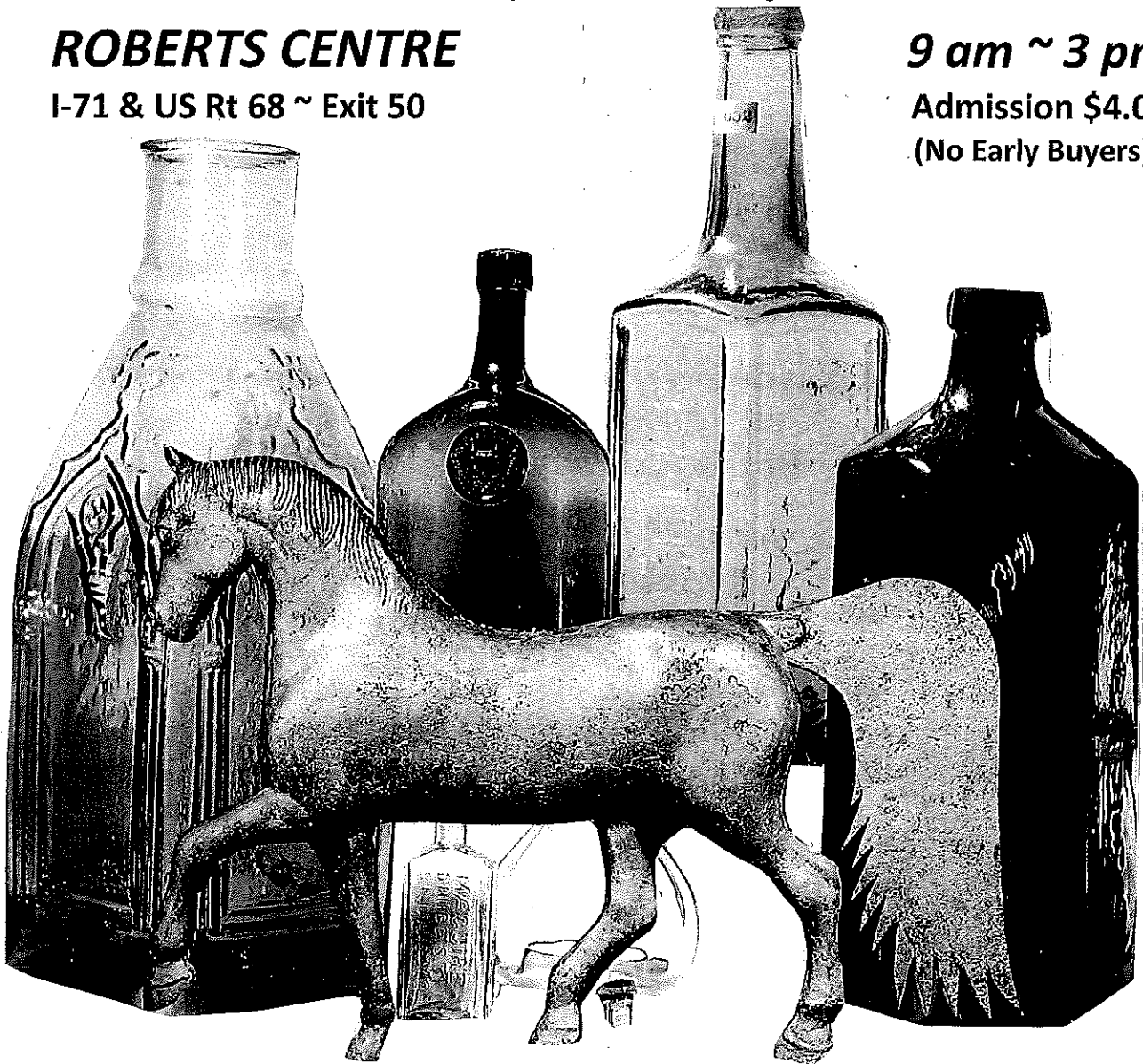

2. Price - \$ 50.00 each. Additional tables will be \$ 30.00 each. (No Early Buyers).

4. Your sales table(s) will be confirmed by mail.
5. Electricity will be available for an additional \$ 75.00. Please let us know in advance.
